



## Technical Specifications for "Peach Mountain Tea"

### PRODUCT DESCRIPTION:

Mountain tea infusion with peach juice

**INGREDIENTS:** Mountain tea leaves infusion (water, Sideritis raeseri mountain tea leaves), peach juice (0,6%) concentrate, grape juice concentrate, apple juice concentrate.

**ADDITIVES:** Flavouring

### MICROBIOLOGICAL:

Total plate count at 30°C /ml < 10 cfu (after incubation at 30 °C for 7 days)

Yeasts & Moulds: < 10 cfu (after incubation at 30 °C for 7 days)

Enterobacteriaceae: \*n=5 c=1 m=0 M=5

Salmonella: absent in 25 g

Listeria: absent in 25 g

\*n=5 (in 5 samples), c=1 (max.1 of them are found), between m=0 and M=5. This means: In 5 samples, the value in 1 of them can be between 0 and 5 while the value of the rest of the samples must be 0 .

Colour.....: Yellow, typical of its origin

Aroma.....: Marked peach tea essence without any alien odour

Appearance.....: The product is clear, has no signs of browning or gelatinous particles and its free from defects, and any foreign bodies
