Full Description: Cut Green Beans are prepared from stemmed, succulent pods of the green bean plant with water and salt. The product is packed in hermetically sealed containers and sufficiently processed by heat to assure preservation.

Quality Characteristics:

Style	Cut - uniform 1 1/2" lengths; sieve as specified. Styles of the cuts must comply with the FDA Standard of Identity (21CFR, Part 155.120).
Quality	Must meet USDA Grade A. Must comply with US Standards for Grades of Canned Green Beans, with modifications noted within these specifications.
Color	The pods or pod sections may possess a slight variation in color, of which not more than 5% by count may vary markedly from a uniform and typical color of young and tender beans of the variety.
Maturity	Not more than 2% by count of the units may possess tough strings. Not materially affected by sloughing.
Defects	Must be practically free from defects. Not more than 5% of drained weight for green beans for all defects. This excludes seeds and seed pieces.
Media	Liquid must be very clear with not more than a trace of suspended material / sediment.

Physical Characteristics:

Seneca Foods Corporation produces our products to meet a target specification at the time of production. Due to the nature of our commodity products, there are factors such as product maturity, variety, moisture level, and the growing conditions of each particular field which may cause a deviation from the target specification as the product cycles through the shelf life.
