The product shall be free of all foreign materials. The product is prepared in accordance with Current Good Manufacturing Practices. This product is Kosher Certified by Orthodox Union. This Product is GMO and Gluten Free. **This product must be refrigerated to maintain the heat through the 9 month shelf life.**

## **SHIPPING AND STORAGE:**

Prepared Atomic horseradish will be filled in sanitary containers, stored on clean, dry pallets, protected from moisture, pests, foreign odors and others contaminants. All containers will be clean, intact and neatly stacked on pallets.

Containers that may be used are: All are identified with a label description and lot number Drums: Fiber drums, two plastic liners approved for use with food, fiber or plastic lids and aluminum or plastic rings secured with a plastic red seal lock.

Pails: Plastic pails with self-locking secure lids.

This product is warehoused and/or stored in a cooler in a manner to protect it from contaminants and extreme temperature conditions.

Maximum storage temperature (ambient) range:  $34 - 45^{\circ}$ F for maximum shelf life. Product may lessen in horseradish hotness if not adequately rotated within the prescribed shelf-life period or if exposed to temperature extremes. Keep refrigerated to prevent heat lost.

FIFO rotation of goods is necessary in order to provide the customer with best quality product. Product heat may decline if not adequately rotated within the prescribed shelf-life period, or when exposed to temperature extremes. HORSERADISH PRODUCT SHOULD NOT EVER BE FROZEN FOR QUALITY PURPOSES.
