A balanced mixture of ground mustard seed, distilled vinegar, and spices resulting in a smooth condiment, colored yellow with turmeric. The product shall be free of all foreign materials. The product shall have typical mustard flavor and aroma. This product is prepared in accordance with Current Good Manufacturing Practices. This product is Kosher Certified by Orthodox Union. This Product is Halal Certified. This product is GMO and Gluten Free.

STORAGE:

Product will be filled in sanitary containers, stored on clean, dry pallets, protected from moisture, pests, foreign odors and others contaminants. All containers will be clean, intact and stacked with no damaged containers or spillage. All packaging used are approved for food contact.

Containers that may be used are: All identified with a label description and a traceable Lot Number or date code and time (retail only).

Retail: ready to fill plastic or glass jars with tamper evident seal.

Drums: Fiber drums, two plastic liners approved for use with food, fiber or plastic lids and aluminum or plastic rings secured with a plastic red seal lock.

Pails: Plastic pails with self-locking secure lids.

This product should be warehoused and/or stored in a manner to protect it from moisture, pests, foreign odors, contaminants and extreme temperature conditions. Maximum storage temperature (ambient) range: 45 - 90°F.
